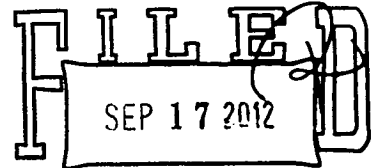

THE COURT

On this court's own motion, San Bernardino County Superior Court appellate division case No. ACRAS1100151, an appeal from the judgment of conviction in superior court case No. V053926ADW, is TRANSFERRED to this court.

Appellate Defenders, Inc., is DIRECTED to select counsel to represent petitioner and submit the usual proposed appointment order to the court on or before 30 days after the date of this order. Appointed counsel is DIRECTED to serve and file an appellant's opening brief on or before 40 days after the filing of the appointment order.

The People, represented by the San Bernardino County District Attorney, Appellate Services Unit, is DIRECTED to serve and file a respondent's brief on or before 30 days after the filing of the appellant's opening brief. Appellant may serve and file an appellant's reply brief on or before 20 days after the filing of the respondent's brief.

Good cause appears in that transfer is necessary to secure uniformity of decision and to settle important questions of law. (Cal. Rules of Court, rule 8.1002.) The questions concern prosecution of stop light violations using automatic traffic enforcement camera systems, which have been the subjects of disagreement between various courts in published cases and are currently pending before the California Supreme Court. (See, e.g., *People v. Borzakian* (2012) 203 Cal.App.4th 525, review granted May 9, 2012, S201474; 143 Cal.Rptr.3d 840 [discussing two published appellate division cases].)
