# SECOND AMENDMENT TO AGREEMENT BETWEEN THE CITY OF BAKERSFIELD AND REDFLEX TRAFFIC SYSTEMS, INC (CALIFORNIA) FOR PHOTO RED LIGHT ENFORCEMENT PROGRAM

#### PARTIES AND DATE

#### WITNESSETH

WHEREAS, Redflex and the City have previously entered into an agreement dated January 16th, 2008 (hereafter referred to as the "Agreement"); and

WHEREAS, Redflex and City entered into the first amendment to the Agreement on July 15, 2009, which restarted the initial 5 year term of the Agreement; and

WHEREAS, under the Agreement, Redflex provides certain services to the City concerning the use of traffic cameras to enforce certain traffic violations in order to improve traffic safety by reducing red-light violations; and

WHEREAS, Redflex and the City wish to extend the Agreement as permitted by the terms of the Agreement;

NOW THEREFORE, in consideration of mutual promises and obligations set forth herein, the parties hereto agree as follows:

- 1. Paragraph 2 of the Agreement entitled TERM is amended in its entirety to read as follows:
- "From the executed date of this Second Amendment, the term of this Agreement will continue for a period of two (2) years (the "Renewal Term"). The City shall have the right, but not the obligation, to extend the term of the Agreement for an additional two (2) year term following the expiration of the Renewal Term (each, a "Renewal Term" and collectively with the Initial Term, the ("Term"). The City may exercise the right to extend the term of this Agreement for a Renewal Term by providing written notice to Redflex not less than thirty (30) days prior to the last day of the Initial Term or the Renewal Term, as the case may be."

All other provisions of the Agreement shall remain in effect.
