The City of Capitola began issuing photo red light citations November 1, 2005. Photo red light revenue reconciliations occur twice each fiscal year. The most recent reconciliation occurred at the end of the first half of FY 15/16 (July 1 through December 31) for the amount of \$43,381.70. I recently received from Ken Wright at the County of Santa Cruz a statement of the revenue collected for FY 15/16.

The amount received for red light fines, including delinquent collections, is \$86,619.52. The amount was derived by adding the total in column "To Cap GF" (\$33,917.42) with the total in column "Red Light Traffic School" (\$51,403.49) plus "Delinquent Collections" (\$1,298.61).

I recommend remitting to ATS the amount of \$37,617.38, which is the total county collections of \$86,619.52 for FY 15/16 less the \$43,381.70 paid for the first half of FY 15/16 and the actual FY 15/16 total court time costs of \$5,620.44 for adjudicating photo red light citations. This is in compliance with our contract. The amount is below the \$125,940 billing from ATS for twelve months of service or \$10,495.00 per month.
