Public Records Request Pursuant to Government Code 6250, et. seq.

Dear Mr.

The City of Menlo Park is in receipt of your Request for Public Records which was made on November 29, 2016 requesting:

- A. Signed copies of all post 1-1-16 updates, amendments, extensions, renewals, or revisions to the City's contract with Reflex and copies of all correspondence to same regardless of whether the date, etc. was finalized or only proposed, where the date of the correspondence was 1-1-16.
- B(1)(a). For each "intersection approach" or "approach" within your jurisdiction, the tabulation or tally of violations recorded and discarded, and of citations issued, during each of the following calendar months: May 16, Jun 16, July 16, Sept 16, Oct 16, Nov 16, Dec 16.
- B(1)(b). If this request is to be fulfilled after Jan. 10, 2017: For each "intersection approach" or "approach" within your jurisdiction, the tabulation or tally of violations recorded and discarded, and of citations issued, during calendar year 2016.
- B(2). Please provide the Redflex Redlight Offender Statistics report, for all approaches, for the calendar month Oct 16. The Redflex reporting system generates this report as a color pdf or xls and this request is one of those digital formats.
- J. A copy of anything sent to, filed with or otherwise communicated to Caltrans by the City of Menlo Park, and Caltrans' replies, on or after Apr. 1, 2016 and regarding any request by the City for a new or renewed red light camera encroachment permit.

Please be aware that the California Public Records Act exempts the city from releasing certain records.

For request A, nothing has changed in the contract in 2016.

For B(1)(a), please see the attached reports.

For B(1)(b), this is not applicable since this request is prior to Jan. 10, 2017.

For B(2), we no longer have access to the Redflex Redlight Offender Statistics report and Redflex will need to be contacted directly.

The Menlo Park Police Department is in receipt of your request for Public Records dated July 10, 2017 in which you request:

A. Signed copies of all post 2-1-17 updates, amendments, extensions, renewals, or revisions to the City's contract with Redflex (I already have a copy of everything prior to then), and copies of all correspondence relating to same regardless of whether the update, etc. was finalized or only proposed, where the date of the correspondence was 2-1-17 or later.

B(1)(a). For each "intersection approach" or "approach" (defined as a red light camera or cameras monitoring any or all lanes of traffic entering an intersection from a single compass direction) within your jurisdiction, the tabulation or tally of violations recorded and discarded, and of citations issued (report title: Customer Management Report), during each of the following calendar months (separately, one month per report): Feb17, Mar17, Apr17, May17, Jun17, Jul17.

- B(2). Please provide the Redflex Redlight Offender Statistics ("RROS") report (colored bar charts or tabular version), or equivalent, for any approach available, for any time 2-1-17 or later.
- J. A copy of all communications between CalTrans and the City (or the City's consultants or vendors) on or after 1-1-17 and regarding any request by the City for a red light camera (photo enforcement) encroachment permit or renewal of the same.
- M. Invoices submitted to the City by Redflex for services rendered during the period Mar17, Apr17, May17 and evidence of payment such as a voucher, check stub, etc.
- R. The annual report covering calendar year 2016, as required by CVC 21455.5(i).

Please be aware that the California Public Records Act exempts the city from releasing certain records. For section A, there is nothing to provide as nothing has changed. For section B(1)(a),

please refer to the attachments provided which should be labeled accordingly. For section B(2), as previously stated in the last response, we no longer have access to those reports so there is nothing to provide. It can be provide but Redflex but there will be a charge. In regards to section M, the invoices have been attached along with the check requisition but the checks are currently being processed so there is not any evidence to provide at this time. For section R, we have not received the accumulated data as of the time of the request.
