Amendment No. 2 to Enforcement and Business Rules

1. This amendment is made by the City of West Hollywood, the Los Angeles County Sheriff's Department and Gatso USA, parties to the Business and Enforcement Rules Agreement dated on February 23, 2017.
2. The Agreement is amended as follows:

As of June 12, 2017 the right-hand turn policy is to be defined as 'right hand turns will be processed by Gatso USA review staff if the vehicle is traveling more than 10mph'. A determination as to whether or not the violation will be issued into citation will be made by the Los Angeles County Sheriff's Department.
3. Except as set forth in this Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms. If there is conflict between this amendment and the Agreement or any earlier amendment, the terms of this Amendment will prevail.

Amendment No. 1 to Enforcement and Business Rules

1. This amendment is made by the City of West Hollywood, the Los Angeles County Sheriff's Department and Gatso USA, parties to the Business and Enforcement Rules Agreement dated on February 23, 2017.
2. The Agreement is amended as follows:
The right-hand turn policy originally defined as 'right hand turns will be processed if the vehicle is traveling more than 10mph' only applied to the warning period.

As of April 12, 2017, the first live ticket date, the right-hand turn policy is to be defined as 'no right-hand turns will be processed into violation though they will be recorded and tracked for statistical purposes.'

3. Except as set forth in this Amendment, the Business and Enforcement Rules Agreement is unaffected and shall continue in full force and effect in accordance with its terms. If there is conflict between this amendment and the Business and Enforcement Rules Agreement or any earlier amendment, the terms of this Amendment will prevail.
